Information	A written approval from Willhem is necessary in order to exchange apartments. The turnaround is between four to eight weeks counting from when Willhem has received a complete application. If an application is denied there is a possibility to apply for approval with the Rental board (Hyresnämnden). Conducting an exchange without approval can result in a termination of the apartment lease. The same applies if an approval has been granted on false information. 	Leaving false information might result in criminal liability for false certification. The new tenant's apartment lease can be terminated if it was granted on false information, if relevant information has been left out or if illegal transactions was made between the exchanging tenants. The one receiving an illegal economic compensation can be prosecuted and punished for this as well as forced to return whatever compensation was received.
